This has been a year of real achievements for the club and of remarkable challenges, notably the continuing Covid-19 pandemic impacts on clubs nation-wide. TREASURER'S REPORT

It has required conviction and dedication to remain open, safely, for bowling and trading and I thank the Board, Committees, members and staff for demonstrating these redoubtable qualities.

Before adjusting for changes in the value of the Clubs investments, the profit from our trading operations was \$111,028 compared to the previous year's loss of \$31,899 which was a substantial increase of \$142,927 or 448%.

After subtracting the net loss of \$13,039 in the revaluation of the Clubs investments, the final accounting profit was \$97,989 compared to a \$48,470 loss in the previous year.

Trading Results

Our profitable result received a boost from Jobkeeper and Covid grants and credits but the greater contribution is due to a general trading increase, and more specifically the bar, Friday night food trucks and BBQs, barefoot bowls, trivia nights and Sunday functions. The bar income increased by about 37% and our bar trading profit increased by 30%. Our gross margin was down from 61.3% to 57.9%. A 'leg up' only goes so far and we have once again demonstrated that we will work hard to get results.

We maintained an increased cash position for the year, as a necessary precaution against further closures.

During the latest closure we have been pleased to be able to undertake another lockdown project, being the downstairs locker room. The generous donation of time and energy by our volunteers allows us to realise a substantial saving to our bottom line, as we continue to bring focus to improving member facilities.

We acknowledge the Women for their hard work and their significant contribution to the Club from fundraising events. We acknowledge the Men for their hard work and their significant contribution to the maintenance and upkeep of the Club landscaping and premises. Your combined volunteer efforts make money and save money for the Club.

Investments

All of our investments have been, where applicable, valued at their last ASX sale price at 31st May 2021

The Mortgage Trusts that have been on our books for some years have been valued at and written down to their trustee's valuation.

We have been active in managing the investments to reduce risk. We have ended the year with excess funds and the board will be placing those as soon as practical, subject to the resumption of trading.

In summary

It has been a pleasure to work with the Board of the Club. The Board members have navigated, and managed, particularly challenging conditions during the year and worked tirelessly on behalf of your Club.

Operating Results

The profit of the company for the financial year amounted to \$97,989.

Objectives

The short and long term objectives of the company are to maintain first class facilities for lawn bowls for the members and to conduct and maintain the club premises as a desirable venue for members and the community.

The company's strategy for achieving these objectives is to maintain the greens at a high standard, to maintain the club premises in good condition, and to encourage new membership for bowling members and social members for the enjoyment of the facilities.

Principal Activities

The principal activities of the company during the year were to conduct lawn bowls for the benefit of members and visitors.

The activities conducted by the directors with the assistance of both men and women bowling members were successful in achieving these objectives.

The company measures its performance by comparison with other bowling clubs in the Sutherland Shire and the assistance of many members performed on an honorary basis.

Members' Limited Liability



1 Summary of Significant Accounting Policies

The financial statements cover South Cronulla Bowling & Recreation Club Ltd (the company) as an individual entity. South Cronulla Bowling & Recreation Club Ltd is a company limited by guarantee, incorporated and domiciled in Australia.

Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards - Reduced Disclosure Requirements and Interpretations issued by the Australian Accounting Standards Board (AASB) and the Corporations Act 2001. The company is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

The financial statements are presented in Australian dollars, which is the company's functional currency, and have been rounded to the nearest dollar.

Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

The financial statements were authorised for issue on 27 July 2021 by the directors of the company.

Accounting Policies

Cash and Cash Equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

Trade and Other Receivables

Trade receivables are recognised initially at the transaction price (i.e. cost) and are subsequently measured at cost less provision for doubtful debts. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

At the end of each reporting period, the carrying amount of trade and other receivables is reviewed and an allowance for doubtful debts is recognised when there is objective evidence that individual receivables are not recoverable.

Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned on a weighted-average basis.

Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the costs necessary to make the sale. Net realisable value is estimated using the most reliable evidence available at the reporting date and inventory is written down through an obsolescence provision if necessary.

Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation.

Property

Leasehold land and buildings are shown at their cost value less subsequent depreciation over the term of the current lease.

Plant and Equipment

Plant and equipment is measured on the cost basis.

The carrying amount of plant and equipment is reviewed annually by the directors to ensure it is not in excess of the recoverable amount from those assets. The recoverable amount is assessed on the basis of the expected net cash flows which will be received from the assets employment and subsequent disposal. The expected net cash flows have not been discounted to present values in determining the recoverable amount.

Depreciation

The depreciable amount of all fixed assets including buildings and capitalised leased assets, but excluding freehold land, are depreciated over their estimated useful lives to the economic company commencing from the time the asset is held ready for use. Properties held for investment purposes are not subject to a depreciation charge. Leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

Leasehold

Leasehold - Make Good Provisions

Under the terms of the new lease there are no 'make good' provisions on termination of the current lease.

Impairment of Assets

At each reporting date, the club reviews the carrying amounts of its tangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the assets carrying value. Any excess of the assets carrying value over its recoverable amount is expensed to the statement of profit or loss and other comprehensive income.

Financial Assets

Financial assets are initially recognised on the cost basis, including acquisition charges associated with the financial asset. The carrying amounts of financial assets are reviewed annually by the directors. The recoverable amounts are assessed from the quoted market value for shares in listed companies or the underlying net assets for other non listed corporations. The expected net cash flows from investments have not been discounted to their present value in determining the recoverable amounts, unless otherwise stated.

Trade and Other Payables

Trade and other payables represent the liabilities at the end of the reporting period for goods and services received by the company that remain unpaid.

Trade payables are recognised at their transaction price. The carrying values are considered to be a reasonable approximation of the fair values. Trade payables are obligations on the basis of normal credit terms.

Employee Benefits

Provision is made for the company's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled. Employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits.

Contributions are made by the company to an employee superannuation fund and are charged as expenses when incurred.

Revenue and Other Income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the company and specific criteria relating to the type of revenue as noted below, has been satisfied.

All revenue is stated net of the amount of goods and services tax (GST).

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

Sale of goods

Revenue from the sale of goods comprises revenue earned from the provision of beverages and other goods to members and other patrons and is recognised at the point the goods are provided as this corresponds to the transfer of significant risks and rewards of ownership of the goods.

Rendering of services

Revenue from rendering of services comprises revenue from green fees and other bowls facilities together with other services to members and other patrons and is recognised when the services are provided.

Interest revenue

Interest revenue is recognised using the effective interest rate method.

Dividend revenue

Dividends are recognised when the right to receive payment is established.

Membership subscriptions

Membership subscriptions paid in advance are initially recognised as a liability. Revenue is recognised on a straight line basis over the membership period, based on the membership category for which subscriptions have been received.

Sale of property, plant and equipment

The gain or loss on disposal of property, plant and equipment is calculated as the difference between the carrying amount of the asset at the time of disposal and the net proceeds on disposal (including incidental costs) and is recognised as other income or other expenses at the date control of the asset passes to the buyer.

Other income

Other income is recognised on an accruals basis when the company is entitled to it.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the Balance Sheet are shown inclusive of GST.

Income Tax

The company is considered to be exempt from income tax under Section 50-45 of the Income Tax Assessment Act, being a non-profit organisation, not carried on for the purpose of profit or gain to its individual members and which was established for the encouragement of a game or sport. Accordingly, no account for income tax has been taken in these financial statements.

Comparatives

Comparative figures have been adjusted to conform to changes in presentation for the current financial year.




